EQUIPMENT RENTAL AND RELEASE FROM LIABILITY, WAIVER OF CLAIMS AGREEMENT

I accept for use the equipment rented to me by Soldier Mountain Holdings LLC. (the "Equipment") and accept full responsibility for its care while it is in my possession. I will be responsible for the replacement, at full retail value of any Equipment which is not returned, and I will be responsible for the costs of repairing any damage to the Equipment, other than normal wear and tear.

SKI EQUIPMENT: I understand that the ski-boot bindings system which I have rented will not release at all times not under all circumstances, nor is it possible to predict every situation in which it will release. I understand that the ski-boot bindings system is, therefore, no guarantee of my safety. I have accurately represented to Soldier Mountain LLC my heights, weights, age, and skiing ability, recognizing that some or all of these factors may affect the settings of the ski-boot bindings system.

SNOWBOARD EQUIPMENT: I understand that the snowboard binding system, which I have rented, is a non-release system. I understand that the snowboard bindings system is no guarantee of my safety.

HELMET EQUIPMENT: I acknowledge that no helmet can protect the wearer against all possible foreseeable impacts and injuries to the head. Reasonably foreseeable impacts may exceed the capabilities of the helmet to protect against injury. The helmet is designed to offer added protection to the head and cannot guard against neck, cervical, spine or any other bodily injuries. I understand that in order to function at its full capacity, this helmet must fit correctly, and chin strap must be fastened, and I agree that Soldier Mountain LLC has supplied a helmet that properly fits me. I understand that the use of a helmet does not and cannot guarantee the safety of myself and my child(ren) and may not prevent injury or death.

I hereby agree to the fullest extent permitted by law, as follows:

1) **TO WAIVE ALL CLAIMS** that I have or may have against Soldier Mountain LLC and all manufacturers and distributors of the Equipment, caused by the use of the Equipment and/or the inherent risks of the sport of skiing.

2) TO ASSUME ALL RISKS INHERENT IN SKIING:

3) **TO RELEASE** Soldier Mountain LLC and all manufacturers and distributors of the Equipment, from all liability for any loss, damage, injury or expense I (or my next of kin) may suffer, caused by the use of the Equipment and/or the inherent risks of the sport of skiing.

4) **I FURTHER AGREE TO INDEMNIFY** and hold harmless Soldier Mountain LLC and the manufacturers and distributors of the Equipment for any loss or damage including any that results from claims or lawsuits for personal injury, death, or property loss and damage arising from my use of the Equipment.
